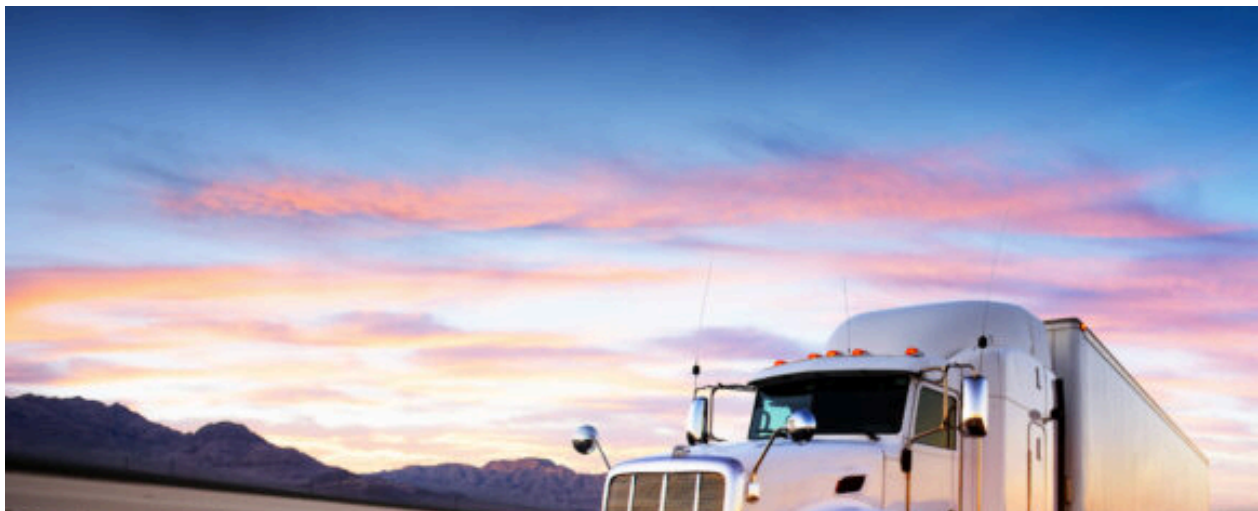

Insurica, one of the largest U.S. brokerages, announced it has acquired Florida-based First Light Program Managers, a wholesale brokerage and delegated underwriter specializing in trucking and marine coverage.

The acquisition, effective this month, is the largest in the 67-year history of the Oklahoma-based Insurica, the company said in a news release. The move capitalizes on a trend in the industry, with net written premiums by managing general underwriters increasing 40% in the last year, Insurica noted.

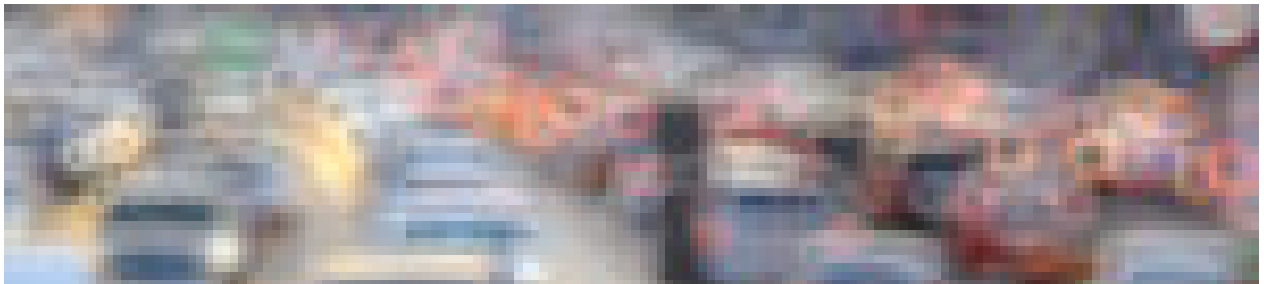
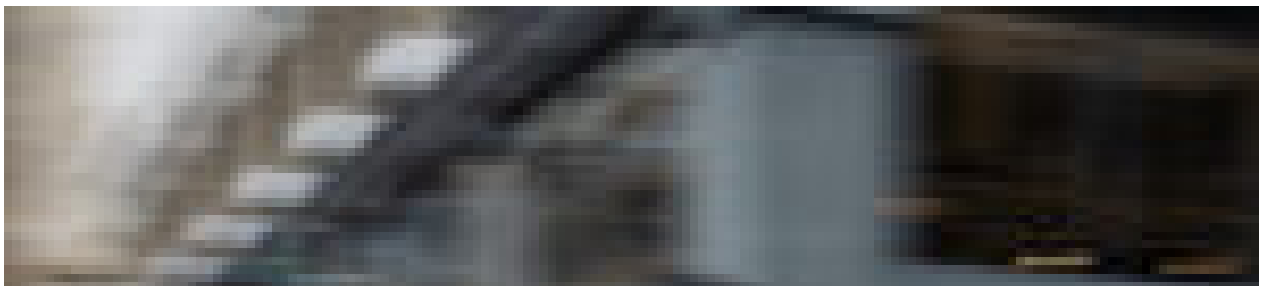
